


INDIVIDUAL - ONLINE AADHAAR BIO BASED DSC PROCEDURE

Navigate to the **Capricorn website** and select the '**Buy Certificate**' option to begin the DSC purchase process.



Choose the type of DSC you wish to purchase from the product selection options. After selecting the **Individual DSC** type, click on the '**Buy Certificate**' tab. If you want **TOKEN** with your DSC, you need to choose TOKEN, else you can select **USB TOKEN NOT REQUIRED**.







Fill in your details including your Name, Email address, Mobile number, and Address. Click on the '**Get OTP**' button. If you have a BP Referral Code, please enter it in its field, and if you don't, you can proceed without a BP Referral Code.

Enter the OTP received on your mobile number. Select the '**Terms of Services**' checkbox and the '**I'm not a robot**' CAPTCHA checkbox. Click on the '**Continue to DSC Enrollment**' button to proceed.

NOTE:- "REMARK" BP can enter any reference in the remark field related to the order and the same will be reflected in **BUSINESS PARTNER PORTAL** under the ORDER section.



Click on the 'AADHAAR BIO' option to proceed with your DSC application.






Now, Install the 'Capricorn Biometric' in your system as shown in the picture below.

NOTE: You need to install the Biometric Device Driver in your machine, There should only be one Biometric Device Driver installed into your machine.

After installing the biometric device driver & the Capricorn Biometric application, Click on 'Click here to connect the bio device'.




Click on the 'Click Here to Connect Bio Device' button.


A popup appears on the screen - 'Please wait. We are searching connected Biometric Devices'.



Once the RD Services Driver is searched, it will redirect you to the next page for further processing and the estimated search time will be two minutes.




If a popup shows 'RD Service not found on your system. Please install RD service and try again' appears on the screen, and then you will need to reinstall the RD service driver of the Biometric device, after doing that restart the system and then try again to connect the device.






After the device is successfully connected, Follow the steps given below:

- Enter the Aadhaar or virtual ID number;
- Select the finger;
- Accept the terms and conditions;
- Enter the Captcha
- Then click on scan and put the selected finger on the device.



Once the thumb has been scanned successfully, Click on the "Next" button to process further.






Please fill in the required details with eKYC ID & eKYC pin:


- eKYC ID should be set according to the customer name with some more numbers or letters to make it distinct.
- eKYC pin is a six-digit pin that you can set according to your preferences.

Select the checkbox to accept the '**Terms of Service**' and IVG. Click '**Submit**' to move forward.






If you have mentioned your PAN number, you have to verify your **NAME** and **DATE** of Birth as per your PAN/NSDL Data.



Verify your email by following the prompts to complete the email verification process.






After Completing the above verification; If you had opted for **TOKEN REQUIRED** at the time of product selection. Then, you have to confirm your delivery address for token delivery.



Along with the delivery address, you can choose options:


- 1. Send Token after downloading DSC.

Then, click the "Confirm and Submit" button.






Now, you will need to submit the 'Application Form'.




Once the application form is submitted, your order will be sent for verification. The verification will be conducted by Capricorn CA. Please wait for this process to be completed. After your order has been verified, you will need to finalize the payment for your order. Make sure to complete this step to ensure the processing of your Digital Signature Certificate.






Once the payment is completed, a prompt will appear. Click on 'CONTINUE TO DSC ENROLLMENT' to proceed to the next steps.




After the payment, you need to eSign your 'Subscriber Agreement'. As shown in the screenshot below, click on the 'Click here to login' link to continue.






You will need to log in using your eKYC credentials.




Upon logging in, your eKYC Dashboard will open. Here, you will see your order listed. Click on the 'Form & Agreement eSign' option to eSign your Subscriber Agreement.






Your Subscriber Agreement will now be signed electronically. This completes the eSign process for your order.



After signing the **Subscriber Agreement**, your order will be ready for download. You have to set your **Download Key** before downloading. You will be able to view your **"ORDER ID, PIN CODE**, and **DOWNLOAD KEY"** on the screen.
