INDIVIDUAL - PAN BASED DSC PROCEDURE


MINIMUM REQUIREMENTS TO PROCESS PAN Based DSC:

- 1. A scanned copy of the PAN card required
- 2. A scanned copy of Address Proof is required.
- 3. Passport size Photo of the applicant in JPG / PNG format.
- 4. In video verification, the applicant must show the original PAN card and address proof.
- 5. The mobile number must be registered in the name of the eKYC applicant and verified by CA through the services provided by Telecom companies.

Navigate to the Capricorn website and select the 'Buy Certificate' option to begin the DSC purchase process.




Choose the type of DSC you want from the product selection options. After selecting the **Individual DSC** type, click the '**Buy Certificate**' tab. If you want TOKEN with your DSC, you need to choose **TOKEN**, else you can choose **USB TOKEN NOT REQUIRED.**






Fill in your Name, Email, Mobile Number, and Address. Click 'Get OTP'. Enter the OTP received on your mobile. If you have a BP Referral Code, enter it; if not, proceed without it. Select the 'Terms of Services' and 'I'm not a robot' checkboxes. Click 'Continue to DSC Enrollment' to proceed.

NOTE: - "REMARK" BP can enter any reference in the remark field related to the order and the same will be reflected in the **BUSINESS PARTNER PORTAL** under the **ORDER** section.




Click on the 'PAN Based' option to proceed with your DSC application.






Enter your name, date of birth, and PAN number as per your PAN card, and click 'Next' to continue.



Please fill in the required details with your eKYC ID & eKYC PIN;


- eKYC ID should be set according to the customer name with some more numbers or letters to make it distinct.
- eKYC PIN is a six-digit PIN that you can set according to your preferences.

Select the checkbox to accept the 'Terms of Service' and IVG. Click 'Submit' to move forward.






Verify your 'Email' by following the prompts to complete the email verification process.



NOTE: - According to **CCA IVG GUIDELINES**, the mobile number must be registered in the name of the eKYC applicant and verified by CA through the services provided by Telecom companies. If the eKYC applicant's name does not match the registered mobile number's name, the applicant cannot proceed with the **PAN-based DSC** and must use different modes. You need to do **"Telecom Service Provider"** verification in Pan Based DSC processing.






After the "Telecom Service Provider" Verification, it will be displayed on your screen.



Upload a passport-sized photograph of the applicant.






Upload the required documents.



Click on "Start Video Recording" to initiate video verification.






The documents that you need to present during the video recording are listed on the video recording screen. Please ensure you have these documents ready before starting the recording.

While recording your video, clearly state your name and the video code displayed on the screen. This helps in verifying your identity and linking the video to your application.



After recording your video, you have to preview it by clicking on the "Play" button and click on "Submit" to complete the video recording confirmation.






Click on 'Continue' to Enrollment process' to continue your DSC application.




After recording your video, you can preview it by clicking the "Play" button. If you find any mistakes or if the video was recorded incorrectly, you have the option to record the video again.






After Completing the above verification; If you had opted for **TOKEN REQUIRED** at the time of product selection then, you have to confirm your delivery address for token delivery.



Along with the delivery address, you can choose options:


- 1. Send Token after downloading DSC.

Then, click the "Confirm and submit" button.






After completing the above verification, you will need to submit the "Application Form".




After submitting the application form, your order will be sent to **Capricorn CA** for verification. Once verified, you'll need to finalize the payment. Be sure to complete this step to process your **Digital Signature Certificate**.






Once the payment is completed, a prompt will appear. Click on "CONTINUE TO DSC ENROLLMENT" to proceed to the next steps.




After the payment, you need to eSign your "Subscriber Agreement".

As shown in the screenshot below, click on the "Click here to login" link to continue.






Now, You will need to log in using your eKYC credentials.




Upon logging in, your eKYC Dashboard will open. Here, you will see your order listed. Click on the **"Form & Agreement eSign"** option to eSign your Subscriber Agreement.






Your Subscriber Agreement will now be signed electronically. This completes the eSign process for your order.



After signing the Subscriber Agreement, your order will be ready for download. You have to set your Download key before downloading. You will be able to view your "ORDER ID, PIN CODE, and DOWNLOAD KEY" on the screen.
